### CONDITIONS — EARLY CLOSING PROGRAM EVENTS 47-50

- Nominations close March 15, 2010.
- All events will be conducted under the rules and regulations of the New Jersey Racing Commission, United States Trotting Association and The Meadowlands.
- Post positions for all events will be drawn by lot.
- Purse distribution 50%-25%-12%-8%-5%.
- Declarations close at the time and date posted on the weekly condition sheet.
- Nomination fee must accompany all nominations. (U.S. FUNDS ONLY). All nomination fees will be added to the final events. **PAYMENT FOR NOMINATION FEES MUST BE IN U.S. FUNDS ONLY. IF PAYMENT IS DRAWN ON A CANADIAN BANKING INSTITUTION, THAT INSTITUTION MUST OPERATE A BRANCH LOCATED IN NEW YORK, NEW YORK.**
- Starting fees must accompany entries at time of declaration.
- The Meadowlands requires six separate betting interests to start in any event or it may be cancelled.
- The Meadowlands reserves the right to reject any entry and return entry fee, declare off any event if conditions warrant, call off any event not filling satisfactorily and place entries in their eligible class if entered incorrectly.
- Should any unforeseeable conditions prevent the racing of any or all events, monies paid will be refunded.
- If for any unforeseeable reason races are cancelled The Meadowlands reserves the right to carry races to future race dates of their discretion.
- All horses shipping to The Meadowlands must have a current negative Coggins. The Racing Secretary shall require proof of such test.
- All horses shipping into New Jersey must have current health certificates.
- Stall space for stakes nominees may be revoked at any time.
- Horses must meet qualifying standards at The Meadowlands.
- The Meadowlands may deduct up to 1% of all fees for the administration of these events.
- All owners and/or trainers nominating or having horses nominated for stakes races at the Meadowlands shall be required to stable said horses at the Meadowlands' facilities prior to the race in which they are entered at a time specified by the Meadowlands. The Meadowlands shall have sole discretion in assigning stalls to particular owners and trainers and shall also have sole discretion in waiving the above stated requirements.
- Declaration fees are non-refundable.
- Those nominating horses to these events are responsible for eligibility. No refunds will be made for ineligible horses.
- A nomination to these events is an agreement to all above terms.
